A motion to approve the reports as written was made by Rudy Dudley with a second from Jerri Chism. All present voted Aye.

6. ACTION ITEMS

6-1. Review, Discussion, and Possible Action to consider a 5-10% rate increase for retired city employees.

A previous City employee asked on behalf of himself and other retirees for a cost-of-living adjustment ranging from 5% to 10%. The City Secretary contacted Texas Municipal Retirement System (TMRS) to discuss. TMRS notified the City Secretary there are currently eleven retirees drawing retirement benefits from the City of Lone Star. The City adopted a repeating 70% Cost of Living Adjustment (COLA), effective January 1, 2001. By repeating, the new COLA rate is automatically granted to all eligible retirees each January, but a retiree must be retired for twelve months and will qualify for the COLA the following January. Cities can adopt COLA at 30%, 50%, or 70% of the increase in the Consumer Price index; therefore, the City of Lone Star has elected the highest COLA percentage allowed.

A motion to take no action on this item was made by Mona Brown with a second from Rudy Dudley. Three voted Aye; One abstained.

6-2 Review, Discussion, and Possible Action to consider incorporating a 3-2-1 tax rate for the City of Lone Star.

6-3. Review, Discussion, and Possible Action for the EDC to pay for the spraying of the hydrilla located at the community boat ramp and the community swimming area.

Rudy Dudley referenced a meeting recently held to discuss the hydrilla problems on Lone Star Lake. Rudy contacted Texas Municipal League (TML) and Texas Economic Development Council (TEDC) to determine if the EDC could pay for the hydrilla spraying at the community boat ramp and swimming area at the City Park. Since the EDC currently has an ongoing project at the City Park, both entities stated the spraying of the hydrilla could be considered as part of the City Park project.

A onetime treatment to spray the hydrilla was estimated to cost \$1,754. Additional treatments may be necessary to kill the hydrilla, but will be scheduled later, as needed. Approximately 40 people have signed up to have their lakefront properties sprayed. The more people participating in the spraying will help reduce the hydrilla growth.

Cody Wommack disagrees with the EDC paying for the spraying of the hydrilla at community boat ramp and swimming area at the City Park. The City doesn't own the lake and the City limit ends at the water's edge; therefore, City or EDC funds shouldn't be spent to spray. The Mayor discussed U S Steel and the Texas Parks and Wildlife had approved the spraying of lakefront properties with approved and environmentally safe chemicals. The usage of carp fish to remove the hydrilla was also discussed.was discussed to assist with the removal of the hydrilla; however, can not be used because 6-4 Review, Discussion, and Possible Action to consider converting the city's paper ordinances into a digitized municode codification system.

Multiple discussions have occurred about the city ordinances needing updated, digitized and uploaded onto the City website. The City Secretary contacted Civic Plus, which recently purchased Municode, a codifier of legal documents for local governments. Civic Plus provided an estimate of 12-16 months to complete the project which includes a full legal review of our ordinances to ensure consistency in code and compliance with state law at an estimated cost of \$8-10K. The annual ongoing cost would be \$1-3K depending on the service and options selected. The council discussed the cost, how to pay for it, and if we would need to get legal approval after Municode makes changes and updates to our ordinances.

A motion to table this item pending additional information was made by Mona Brown with a second from Rudy Dudley. All present voted Aye.

6-5 Review, Discussion, and Possible Action to schedule a public hearing date to discuss the proposed property tax rate, General Fund Budget and Water & Sewer budgets.
