6. ACTION ITEMS

6-1: Review, Discussion, and Possible Action by the Council on comments from Jerry Stoermer regarding grant funding for the fire department.

Jerry Stoermer presented bunker equipment and explained the current state of the Fire Department equipment. Mr. Stoermer explained grants that have been applied for and grants that are still needed.

A motion to have the SCBA tank air compressor repaired for the amount of \$1,900.00 and to use \$50,000.00 of a \$100,000.00 CD to pay for the purchase of bunker gear, 14 SCBA packs, 21 45 minute SCBA bottles and extension ladder was made by Trent Duke, with a second by Lynn Cox. All present voted aye.

6-2: Review, Discussion, and Possible Action by the Council to approve City of Lone Star Tax Roll Approval and Tax Levy Resolution for Tax Year 2020.

A motion to approve the City of Lone Star Tax Roll Approval and Tax Levy Resolution for Tax Year 2020 was made by Trent Duke, with a second by Jerri Chism. All present voted aye.

6-3: Review, Discussion, and Possible Action by the Council to consider adopting a \$20.00 trip charge for subsequent trips by the Public Works Department to turn on water service. Customers are informed at the time they pay their deposit for water/sewer service, someone must be home between the hours of 3:30 pm and 4:30 pm, when the Public Works Department comes to turn on the water. On multiple occasions, there has been no one home, resulting in multiple return trips. The charge would only be applied if only more than one attempt is made.

A motion to approve a \$20.00 trip charge for subsequent trips by the Public Works Department to turn on water service was made by Mona Brown, with a second by Jerri Chism. All present voted aye.

6-4: Review, Discussion, and Possible Action by the Council to consider a request for variance of Ordinance 181 by Trent Duke to temporarily place a camper at 513 North Main for overnight security.
