- 3. CITIZEN COMMENTS: Cody Wommack spoke against the proposed Ordinance 285, An Ordinance of the City Council Establishing Regulations of Food and Food Establishments in the City of Lone Star. Mr. Wommack stated that the proposed Ordinance only regulates what is regulated by State law. He feels the proposed Ordinance makes a business less likely to succeed and we do not need more government or regulation.
