A motion to approve Minutes of the Regular Meeting on October 18, 2018 was made by Trent Duke, with a second by Jerri Chism. All present voted aye.

6. NON-ACTION ITEMS

6-1: Fire Marshall Bobby Livingston will present his notice of retirement to the Council.

Fire Marshall Bobby Livingston spoke, thanking the City for his over 40 years of service.

6-2: The Christmas parade will be December 10, 2018 at 5:30 pm. Entry forms for the parade are available at City Hall or on the City's website.

6-3: Police Chief Steven Blythe will introduce Police Reserve Brooke Elder to the Council.

Police Chief Steven Blythe introduced Reserve Officer Brooke Elder to the Council.

6-4: Mayor Randy Hodges will recognize Judge Bob Mattox's 46 years of service as Lone Star Municipal Judge and Tina Sparks's service as Municipal Court Clerk and Associate Judge and make Proclamation.

7. DISCUSSION/ACTION ITEMS

7-1: Review, Discussion, and Possible Action by the Council to consider the request of Anjia Harper for a variance of Ordinance 181, which prohibits the placement of a mobile home outside of a mobile home park. Ms. Harper wishes to place a mobile home on Crossland Road (off of Forrest Hill Road).

Ms. Harper spoke and informed the Council she owns the property and has only just now been able to clean-up the property. A motion to grant a variance to Ordinance 181, allowing Anjia Harper to place a mobile home on Crossland Road, with the condition that the mobile home be less than five years old, was made by Keith Reiter and second by Jerri Chism. All present voted aye.

7-2: Review, Discussion, and Possible Action by the Council to approve an Interlocal Agreement with Morris County for use of maintenance equipment.
