## 2. ACTION ITEMS

2.1 Review, Discussion, and Possible Action by the Council for drawing variance at 217 West Germany provided by Rocky Point Adventures (tabled from 5/20/21)

A special meeting was called to resolve an issue that was brought to the council's attention after the May 20, 2021 council meeting. 217 West Germany is zoned as residential property which can be used to build a single-family dwelling and/or for agricultural growth. Issuance of the variance is necessary to put a roadway in for a turn-around of vehicles traveling to and from Rocky Point Adventures and to allow a handicap parking spot to be placed at this location. The variance presented to council also included picnic tables at this location. Some neighbors expressed concerns of the picnic tables being located here because of trash being left behind. Rocky Point Adventures moved the picnic tables from this location to the concession area prior to their grand opening. The tables are still located near the concession area; therefore, the property is being used as a turn-around and for a handicap parking.
