2. ACTION ITEMS:

2-1: Review, Discussion and Possible Action to adopt the proposed City of Lone Star General Fund and Water and Sewer Fund Budgets for Fiscal Year 2020 – 2021.

A motion to adopt the City of Lone Star General Fund and Water and Sewer Fund Budgets for Fiscal Year 2020-2021 was made by Mona Brown, with a second by Jerri Chism. All present voted aye.

2-2: Review, Discussion and Possible Action to ratify the property tax increase reflected in the budget. This budget will raise more revenue from property taxes than last year's budget by an amount of \$9,186.00, which is a 0% increase from last year's budget.
